- Completed a recognized fellowship in forensic pathology with board certification by examination from the ABP (you may be board eligible in forensic pathology so long as you plan to write and pass the FP board exam within two years of commencing employment)
- Excellent written and interpersonal communications skills
- Have the capacity to work in highly stressful and demanding environments and situations, and, with class, handle time periods and people that may be very challenging
- Ability to successfully complete a Background Investigation (including criminal background check and drug/alcohol screening)
- Must be able to legally work in the USA


